It may not be easy for entrepreneurship education to gain the public's attention and urge of support, but we know that the new generation will affect the future economic development and international competitiveness of the country. As we are entrusted with this responsibility we will continue to focus on this mission. I truly believe that one day there will be many Chinese entrepreneurs with high integrity and innovative capability. They will make significant contribution to the history of human beings. This is a project of the souls of mankind, a life changing life architecture. Our work is meaningful, ordinary but extraordinary.

# 秘书长寄语

### Speech from the Secretary General

在一次新员工招募的面试中,我问申请者: "你最期望的工作环境和平台是什么样的?最不能忍受的是什么样的?"得到的回答是:"我希望在一个业务稳定的机构,不是总变来变去。"听到后不禁微笑,回想 BCF 过去十年的经历,真是验证了德鲁克先生所说的"唯一不变的就是变"这句话。2007 年是 BCF 在国内开展创业教育项目的第五年,机构进行了第一次大的战略调整。虽然非常不舍得,但还是从集中的原则出发,决定将原来 5 个领域的 40 多个不同类型的项目有计划地放弃,将资源集中在自己的优势项目 NFTE 光华公益创业教育与德鲁克非营利组织能力建设两个核心。

2012 年是开展工作的第 2 个 5 年,又是整个机构业务调整的关键一年,核心业务从 2 个集中为 1 个——"光华公益创业行动"。通过推广 NFTE 的创业课程与组织相关的学生商业实践活动,致力于在中国搭建创业教育的公益平台,使更多的企业、个人参与其中,进而提升学生的创业意识与企业家精神。

针对新的战略,2012 年 BCF 进行了一系列的调整与变化,从选择能够更有效的实现战略目标的核心项目活动,到界定与合作伙伴的关系以及重组内部团队与人员结构…… 变化的整个过程有争论、有选择、有计划的放弃,也有痛苦,但更多的是大家的思想冲击、对机构业务的深入分析与理解、以及对未来的期待。

新的起点,我们整装上路……


In a new staff interview, I asked the applicant, "What is the kind of environment and platform you expect to have at work? And what is the most unbearable kind?" The answer I got was, "I hope to stay in an organization with stable business, without constant changes." It brought a smile to my face. In retrospect of the past 10 years' development of BCF, the history indeed proved the famous word of Mr. Peter Drucker, "The only thing that does not change is the change itself." 2007 was the 5th year for BCF to start promoting entrepreneurship education in China and also the first time for us to experience an overhaul on strategy. Although it was not easy at heart, we chose to stop over 40 types of projects in 5 fields step by step, leaving two advantages projects where our main resources can be focused on, namely, NFTE Bright China Philanthropy Entrepreneurship Education Program, and Peter Drucker NGO Capacity Development.

Another 5 years passed when it came to 2012, which was also another key year for the organization to embrace adjustment. The core business then has been refocused from two to one – "Bright China Entrepreneurship Education Program". By promoting the NFTE entrepreneurship courses and organizing the business practice for students, we are committed to build a philanthropic platform of entrepreneurship education in China and involve more enterprises and individuals in it so as to improve the students' awareness of enterprising and spirit of entrepreneurship.

Echoing with the new strategy, BCF has made a series of transformation and adjustments. From choosing the key project activities that can more effectively realize strategic targets, defining the relationship with partners, to re-organizing the internal team and the structure... we experienced various arguments and difficult choices, sometimes we had to give up one by one and sometimes we swallowed pains shoulder to shoulder. While we also gained more, such as brainstorming and inspiration for the team, deeper analysis and understanding of the organization's business, as well as the longing for brighter future.

At the new starting line, we are setting out again full of hope..



BCF encourages them to do part-time work to support themselves, or start up own business with small funds, which could improve their practical abilities and overall quality and help them grow more independent and free from poverty-driven life and strong enough to help others and contribute to local economy. In this way the objective of Bright China Entrepreneurship Education Program, "Promote entrepreneurship education, and make a positive life", will also be realized.

### 教研特色

### Features of the Training Program

光华创业课程源自全球创业指导基金会(NFTE)的原版教材 -《How to start and run your business》课程采用参与式教学方法,倡导在生活中学习、快乐中学习、实践中学习的教学理念,注重激发学员的自尊心和自信心;增强学员的诚信意识、爱心和社会责任感。

光华与各个地方教育局及职业技术学校保持合作,始终关注创业教育领域并根据受众需求不断调整和开发新的课程。经过多年的摸索,光华通过与工商界和教育界合作,在大中专院校和司法系统开展创业、财务、社会责任等课程,用一流的企业和大学生志愿者、教师和一手的经验,帮助学生提升就业准备、创新创业、金融理财和可持续发展的综合素质。

The courses of Bright China Entrepreneur Education Program are developed based on the original textbook of NFTE , How to Start and Run Your Business. The courses are delivered in a participatory way, promoting the idea of learning in life, learning in happiness and learning in practice, which deliberately protecting the dignity and confidence of students, and enhancing their awareness of honest, compassion and sense of social responsibility.

BCF has constantly cooperated with local education bureaus and vocational schools, paying close attention to the field of entrepreneurship education, and flexibly adopting adjustment and developing new courses based on the needs of various recipients. Based on many years of practice and cooperation with industrial and commercial and educational sectors, BCF has developed a series of courses on entrepreneurship, finance, social responsibilities which are applicable for college students and inmates groups. The first-hand experience from first-class enterprises, university student volunteers, and teachers has helped students improving their comprehensive abilities in preparing for a job, making innovations, starting up business, financing, and developing sustainably.




### 教师发展

### **Development of CET Teacher Training**

创业认证教师(Certified Entrepreneurship Teacher, CET),推广与实施创业教育的主要力量。截至 2012 年,北京光华慈善基金会培训教师达 1949 人。2012 年,开展 10 期实习 CET 认证培训班,认证实习 CET 349 人;开展了 5 期 CET 认证培训班,认证实习 CET 126 人;认证高级 CET 3 人;培养创业志愿讲师 3 人。

Certified Entrepreneurship Teachers (CETs) are the core force to promote and implement the entrepreneurship education. By 2012, the number of CETs trained by Bright China Foundation reached 1949. In 2012, 10 sessions of junior CET certification training classes were held, in which 349 junior CETs were certified; 5 sessions of CET certification training classes were held, in which 126 CETs were certified; 3 super CETs were certified, and 3 volunteer teachers of entrepreneurship were trained.

## 校友支持 Alumni Support

光华慈善基金会一直致力于在创业校友的创业生活中能够提供更多的支持和指导。积极探索建立校友会的模式,发展校友群网络平台,打造光华校友群人才库,让更多的校友能够共享资源,分享经验。与合作伙伴成功的开办了"创业夏令营"主题活动、"校友会"和"光华创业精神大赛"等系列主题活动。

Bright China Foundation has been committed to provide more support and guidance to alumni in their business. It actively explores new mode of alumni association, develops the communication network platform and talent pool, which allows more alumni to share resources and experience. Various events, such as Summer Camp of Entrepreneurship, Alumni Association, and Bright China Entrepreneurial Spirit Award (BESA), were successfully held with help from partners.

#### **Bright China Entrepreneurial Spirit Award (BESA)**

This nationwide business plan competition has been organized by BCF annually to encourage alumni to practice and develop the entrepreneurial spirit in study and life.

The Bright China Entrepreneurial Spirit Competition in 2012 was widely supported by partners. 2420 alumni from 120 teaching sites of 10 areas attended the semi final competition of the youth group, 1175 alumni from 56 teaching sites of 5 areas attended the semi final competition of "Life Inspiration Program", and 15 alumni attended the national final contest, including one from Hong Kong.

New York Stock Exchange Foundation, Ernst & Young PLL, and Cummings (China) Investment Co. Ltd funded the final contest of 2012 BESA, and provided encouragement and support to the finalists as expert judging panel. Ms. Amy Rosen, CEO of NFTE, also viewed the contest, had a close communication with the participants and highly commended the contest.

面向光华创业教育学员及校友,其宗旨是通过创业基金鼓励和支持校友进行创业实践,重点支持微小型创业和小企业初创阶段的启动资金。

2012年,创业基金申请人数达到 35人,比 2011年度增加 35%,发放资金¥185,000元。创业基金还款率达 100%,首批申请者在清还全部本息后续借率达 100%。光华创业专家团主要来自社会的中小创业者、专业人士、中高层管理者,为 139人次提供了咨询服务,比 2011年度增加 162%。

The Micro Loans are set for students and alumni of BCF entrepreneurship education to encourage and support their practice in doing business with the micro loans. It gives priority to support micro businesses and provide start-up capital for small businesses at the beginning stage.

In 2012, 35 alumni applied the micro loans, 35% increased than 2011, and the released fund reached 185,000 Yuan. The returning rate of the entrepreneurship fund was 100%. And all the first batch of applicants renewed their application after paying off principal and interest. The entrepreneurship expert panel of BCF was composed of the entrepreneurs from small and middle businesses, professionals, middle and high level management, who provided consultation service for 139 person-times in 2012, 162% increased than 2011.

### **Partners**

在区域化项目发展的思路下,截至 2012 年,光华公益创业行动与 21 个合作伙伴建立正式的合作关系。共有 38,905 位校友学习了创业课程,比 2011 年度增长 35%。

The main working mode of Bright China Entrepreneurship Education Program: working with educational sector, judicial and administrative sector, non-profit organizations and other related organizations to develop entrepreneurship education, and promote the sustainable development of entrepreneurship education in China.

With the idea of regionalized development of programs, Bright China Entrepreneurship Education Program had built partnership with 21 partners by the end of 2012. 38905 alumni attended the courses of entrepreneurship education, which showed a 35% increase compared with 2011.

# NPO 德鲁克学习会 Drucker Learning Society for NPOs

西安讲座 Lecture in Xi'an



通过系统的组织课程与读书会,NPO 德鲁克学习会帮助学习者厘清管理者的角色,建立起以贡献、责任和成果为核心的管理者价值观。培养时间记录、分析从而反省自我的习惯,建立富有生产力的人际关系。学习发现自己和他人优势的方法,更好的发展自己、辅佐上级、激励同事和下属奠定条件。学习建立决策的基本程序,学习组织团队实施有效决策。帮助社会组织从业人员深入了解非营利组织管理的关键概念。构建管理语言,凝聚组织资源,达成组织目标。

2012年, NPO 德鲁克学习会项目共计为 1188 名社会组织人员提供了 27 期能力建设培训,其中包括 12 期课程,15 期读书会与讲座。

By holding systematic courses and reading parties, Drucker Learning Society for NPOs helped learners have a clear awareness of the manager's role, and build the manager's core values of contribution, responsibilities and result. It helped learners develop a habit of building a record by time and analyzing and introspecting on themselves, thus constructing a productive interpersonal relationship. The learning also included the methods of finding merits of yourself and the others, so that one can better develop himself, support the superior, and encourage the peers and subordinates; It helps learners to get the basic procedure of making decisions, organizing the team to implement effective decisions. It also helped the employees of social organizations have a deeper understanding on key concepts of managing non-profit organizations, learn how to organize management language, gather organization resources, and achieve target of the organization.

In 2012, Drucker Learning Society for NPOs held 27 sessions of capacity building training for a total of 1188 people from social organizations, including 12 courses and 15 reading parties and lectures.

《社会组织的创新》讲座,特别为社会组织的领导者分享了关于社会创新与功能社会发展的重要意义,特别对社会组织而言,需要通过创新为客户创造出新的价值。通过分享德鲁克的社会创新观点,帮助社会组织的领导者们学习到"目标管理与自我控制",如何帮助组织的员工在其参与制订和认同的目标下,自主地做出决定,运用所长,采取行动,并一步一步看到预期结果的出现。

The lecture of "Innovation of Social Organization" shared with the leaders of social organizations about the significance of social innovation and the development of functioning society. Social organizations especially need to create new values for clients through innovation. By sharing Mr. Drucker's concept of social innovation, the lecture helped the leaders of social organizations learn "Objective management and self-control", which includes how to help the staff, under the objective jointly made with them, make decisions actively, take actions with their merits, and watch how the expected result will come out step by step.



NPO 德鲁克学习会在自我评估工具的基础上,开始逐步探索组织教练式的服务模式,来积极应对社会组织面临的发展中的难题与挑战。通过为处于发展期和上升期的非营利组织提供组织教练服务,引导机构理事会、员工、捐助人、志愿者等的共同参与,并运用教练式跟踪服务来帮助在实施中有效调整目标,最终帮助机构努力达成使命,为社会做出贡献。

Drucker Learning Society for NPOs also started to explore the service mode of organization coaching on the basis of self-evaluation tools, seeking to actively answer the difficulties and challenges in development of social organizations. By providing the organization coaching service to NPOs in the developing and rising stage, it guided the participation by all levels, from the organizations' board, staff, to donors and volunteers. The follow-up service of coaching contributed to the adjustment of the objective in the implementation, so that the mission could be achieved finally and the organization could make better contribution to the society.

The course of "The Financial Management of the non-professionals" was held to help social organizations learn the basic financial management tools and ideas, thus enhancing credibility of the organization in financial perspective. At a time when NPOs are facing the crisis of accountability, it is important to help social organizations build the concept of financial management, thus to ensure the long-term and regular development of the organization by answering to the accountability with initiative.

The course of "The Eight Basic Management Skills for NPOs" was formally launched. This course was focused on the analysis of common issues in management, such as planning, effective communication, time management and incentive, etc. It helped learners identify the reasons for problems, and practiced in class with real cases. Using collected essence from the books of Mr. Drucker, the course adopted interactive and case studying teaching method and combined with practical work, which helped improve the management efficacy of NPO employees and the organization alike.

### **Education Support Program**

北京光华慈善基金会从 2005 年起为陕西省交口光华中学和 四川省宣汉县龙泉学校贫困学生建立捐赠平台,资金来源于内部 员工、志愿教师、光华校友、社会人士等。他们希望用自己的力 量减轻贫困学生上学中生活费问题,坚持让贫困学生完成学业。

2012年,北京光华慈善基金会继续为陕西省延长县交口光 华中学提供办学经费和教师质量奖, 受益师生人次达 258 人, 全年拨款 32.9 万元。

项目经过六年多的深化与调整,2012年奖助学标准调整到 1000元/人/学年。全年共为94名学生提供助学金。

It was from 2005 that BCF started to build a donating platform for poor students in Longquan School(Xuanhan, Sichuan province) and Bright China Middle School(Yanchang, Shaanxi province). Donations were from BCF staff, volunteer teachers, alumni, and people from the society, which helped relieve the living burden of poor students and support them to be absorbed in study.

In 2012, BCF continued to provide education funds and the teaching quality award to Bright China Middle School (Yanchang County, Shaanxi Province). 258 person-time benefited from the 329, 000 Yuan donation in the year.

According to six years' experiences, the subsidy to students was adjusted to 1000 Yuan per person per school year in 2012. In total 94 students received the subsidy from BCF in this year.

The 5th session of Management Camp for College Students held in Plato Theater, 2012

灯塔行动项目旨在开展全国性德鲁克管理训练 营等系列活动,支持有志学习、研究、实践德鲁克 思想的学生社团组织;系统、全面的指导大学生学 习、实践德鲁克管理思想,并学会科学的管理自我, 服务组织、贡献社会。

2012 年对灯塔行动而言至关重要,运营团队明确并修订了德鲁克青年社区第二个发展阶段的愿景使命和运营模式。新的模式使得灯塔行动用更富有有效率的方式对 10000 余名大学生进行了管理学知识的培训,为社会创造了大学生自主的学习时间长达 2.8 万个小时。在项目整体策划、教学产品研发、社团能力提升、品牌建设,团队建设和发展 5 个方面取得了突破性的进展。

The Lighthouse Action project aims at carrying out a series of activities including Drucker management training camps nationwide, and providing support to student organizations who are interested in learning, researching and practicing the thoughts of Mr. Drucker. It guides university students to learn and practice Drucker management ideas in a systematic, comprehensive way, and learn to scientifically do self-manage, serve the organization, and contribute to the society.

2012 was a key year for Lighthouse Action. The management team clarified and revised the mission and operating mode of the Drucker Youth Community in the second stage of development. The new mode enabled Lighthouse Action to train over 10000 university students with management knowledge more efficiently, which created 28,000 hours of active learning time of university students for the society. Breakthroughs were made in 5 areas, namely, the overall design of the project, the research and development of the teaching products, the capacity improvement of student organizations, the brand building, and the team building and development.
